President's Welcome



It is my great pleasure to welcome all of you, from across the globe, to the 2024 Society for Longitudinal and Lifecourse Studies Conference being held this year at the University of Essex in Colchester, England. This year's theme is *Inequalities Across Life Courses and Generations: Interdisciplinary Perspectives*. We have a full programme of excellent keynote talks, concurrent sessions and interactive opportunities that will provide the chance for delegates to explore the wealth of new knowledge that can be generated by bringing together experts across traditional disciplinary siloes to enable a better understanding of what contributes to health and wellbeing outcomes across the lifecourse and across generations. The programme this year highlights the inequalities

that are experienced within and across populations in terms of differential opportunities for optimal development within the broader societal contexts in which they live. Inequalities have persisted across time and generations and understanding how to reduce their causes as well as mitigate their impacts and their societal and economic costs is at the core of much of the life course and longitudinal research that we collectively undertake.

During this conference we have the chance to celebrate the efforts of researchers and teams who continue to collect information about the complex lived realities of everyday individuals and families. These curated collections that detail the progress of ordinary life courses provide a rich and powerful resource to explore how we might improve wellbeing for our own populations with context relevant and timely interventions that are evidence based. We are particularly grateful that this year the conference is being hosted at the University of Essex where "Understanding Society" is based. Understanding Society is a remarkable household longitudinal study that provides a unique set of information about families and households across the UK and is used widely by researchers and policy makers to generate evidence relevant to addressing inequalities over time and across generations. We are also extremely grateful to our sponsors – Wellcome, the UK Longitudinal Linkage Collaboration and the UCL Centre for Longitudinal Studies – for supporting this meeting and more generally for their support of longitudinal and lifecourse research.

It is exciting to see we are increasingly finding ways to come together as a community of practitioners working in life course and longitudinal research to explore innovative ways to collect information from participants while minimizing participant burden, as well as adapting and harnessing innovative new methodologies to interrogate the information in a way that is respectful of the complexity of the inter-relationships between data points across time and place, and respectful of the individuals it relates to. At this conference we will consider how we can support each other as a community of researchers, and also how we might combine our efforts to gain a more nuanced understanding of what works to improve lives and support populations to flourish across different temporal and socio-political contexts.

I would like to express my particular gratitude to Meena Kumari and her team at the University of Essex for their commitment to facilitating and hosting this conference. It is such a privilege to be able to gather in person to enjoy formal sessions and informal opportunities to network with our global peers as well as to build new relationships that will ensure this field of research is sustained for future generations of scholars and for the benefit of the diverse populations we serve. My huge thanks also go to Cat Westlake who keeps everything running smoothly for the society. Her efforts are enormous and usually unseen.

This conference honours the legacy of some of our inspirational leaders who have been pioneers in the field of life course and longitudinal studies over many decades. We stand on their shoulders as we look to the future of the society that you are all invited to participate in. I look forward to welcoming you to these sessions and opportunities and I hope you leave this conference with a renewed energy to undertake research that can make a difference to everyday lives and help to close the gap between those in our populations who easily thrive and those who are being left behind.

Welcome From Your Hosts



We are delighted to welcome you to the Annual meeting of the Society for Longitudinal and Lifecourse Studies (SLLS) conference 2024 at the beautiful Colchester campus of the University of Essex.

This year's theme *Inequalities Across Life Courses and Generations: Interdisciplinary Perspectives*, was chosen to highlight the strengths in the SLLS community and the overlapping research focus in the Institute for Social and Economic Research (ISER). Inequalities have persisted across time and

generations and the use of interdisciplinary approaches to understand how to reduce their causes as well as mitigate their impacts and their societal and economic costs is at the core of much of the life course and longitudinal research that we collectively undertake.

ISER is a leading, prize-winning social science research institute bringing together researchers from diverse fields and backgrounds for over 30 years and encouraging interdisciplinary collaborative research. We host the ESRC Centre for Microsocial change (MiSoc), a longstanding Centre focused on inequalities research, which has led a variety of projects on how individuals and families respond to change. Building on its success with the EUROMOD, ISER has recently established the Centre for Microsimulation and Policy Analysis (CeMPA), that uses microsimulation modelling techniques and tax & benefit systems to understand family & gender, health & wellbeing, population change & labour market dynamics. Of particular interest to SLLS, we are involved in the generation, development, and maintenance of social surveys: we house *Understanding Society*, Survey Futures and contribute to the European Social Survey. *Understanding Society*, one of the largest household panel surveys in the world, started in 2009, and builds on and incorporates the long running British Household Panel Survey (1991-2008) also housed at ISER. By following individuals every year across their life course, the study has enabled research into changes in the lives of UK residents over the last three decades. The study promotes research across disciplinary divides by combining rich biomarker and social data, some of which will be evident at the conference this year.

The University of Essex is a powerhouse for social science research and is in the top ten in the UK for economics and sociology. The University has recently established the Institute for Public Health and Wellbeing to harness this expertise and work across disciplines with science and health, the arts and humanities to address the root causes of health inequalities. Further, the University hosts the UK Data Archive, home to the largest collection of UK datasets, many of which have featured in presentations at past and the current conference.

The conference will be held on our beautiful campus in Colchester. Although our University only goes back 60 years, you can be part of ancient history here too - our campus parkland was originally a deer park, with oak trees that go back to medieval times and a parkland that was painted by John Constable in the early 1800s. Colchester is Britain's oldest recorded settlement, founded by the Romans over two thousand years ago. Our city has a rich and varied heritage, with Roman, Saxon, and Norman history all still visible in the city centre and street layout. A short stroll around Colchester will introduce you to Roman walls, medieval priory ruins, the quaint Dutch quarter and our Norman castle. Nearer our campus is the pretty village of Wivenhoe, where there are scenic walks along the quayside, a well-stocked village bookshop (and several excellent pubs).

Thus, SLLS will be hosted in an inspiring and welcoming academic environment with an exciting programme comprising four keynote lectures, two invited talks, three panel sessions, 52 symposia and paper sessions organized in six parallel strands, six SLLS group meetings (delegates encouraged to attend), and a poster session, complemented with three pre-conference workshops.

The programme provides new findings on a broad range of topics, information on available data sets for scientific use and introduces new methods in data analysis. There will be opportunities for networking during the welcome reception, coffee breaks, and the conference dinner, including an evening out for early career delegates.

SLLS is truly interdisciplinary, and so is its 2024 conference – not only regarding its participants and contributions, but also with respect to the organizing team with our diverse background in Epidemiology, Sociology, Economics and Demography. We are grateful for the financial support of Wellcome, the UK Longitudinal Linkage Collaboration (UK LLC), and the UCL Centre for Longitudinal Studies (CLS).

The UK Longitudinal Linkage Collaboration is the Trusted Research Environment for longitudinal research, funded by UK Research and Innovation, Medical Research Council and the Economic and Social Research Council. This unique resource enables cross-sector research and supports research responses to immediate situations and future policy needs.

The UK LLC currently links data from 22 Longitudinal Population Studies (with more LPS joining soon), to:

- Participants' NHS England and NHS Wales primary care, secondary care, community care, mental health records, cancer and mortality register, and prescription dispensing data
- Air pollution data

In the next few months, the following linked-data will also be available:

- **DWP data** items relating to employment payments, workplace pensions, employment cessation payments, nature and source of income, pensions, share schemes, Child Benefit Extract (CHB)
- HMRC data Self-Assessment and PAYE RT (Pay As You Earn)
- Geospatial noise (UK long-term average noise exposure) and area of green space
- **Encrypted property indicator** (UPRN) and UK neighbourhood geography (LSOA and MSOA) to allow linkage to indices of multiple deprivation
- NHS Scotland data

All data is held in a Trusted Research Environment which meets the highest Information Security standards (ISO2701 and Digital Economy Act Accredited).

UK researchers can apply to access data from many Longitudinal Population Studies through a single application, typically taking 12 weeks from application to data provision. CENTRE FOR LONGITUDINAL STUDIES


The UCL Centre for Longitudinal Studies is home to a unique series of UK national cohort studies. Our studies follow multiple generations of people across the whole of their lives. The majority of our studies are birth cohort studies that started at birth, or in the first year of life. Two of our studies (Next Steps and COSMO) began during adolescence. All our studies are nationally representative.

By collecting information from the same people over time, we build powerful resources for research and policy development. For more than 60 years, evidence from our studies has helped to inform and shape the world we live in today.



This event brings together key scientists and policy makers to highlight examples of how longitudinal survey data has contributed to a better understanding of children and young people lives in different countries and the ways in which social policy interventions benefit from investments in survey data infrastructure.

High quality longitudinal data on child development and wellbeing is routinely used to answer scientific and policy questions wherever such data is collected. Its importance in understanding national contexts and in developing national interventions to meet challenges related to inequalities of education, health and poverty is widely accepted.

In many countries, however, there is a critical gap in their data infrastructure on child development and wellbeing as they do not yet collect longitudinal data on children hence there are significant gaps which suggest that much policy related expenditure on child wellbeing is not supported by robust evidence. The Growing Up in Digital Europe (GUIDE) research Infrastructure is seeking to address this significant data gap at the same time as making it more possible to undertake comparative analysis through the collection of harmonised longitudinal data across Europe.

This event, organised by the GUIDE study team, will include research evidence from longitudinal studies and policy perspectives on child and youth well-being, as well as giving an overview of the Growing Up in Digital Europe study.
